如果投标人为境外注册公司，需提供有效的公司登记注册证明；

A. The bidder within the customs territory shall provide valid independent legal person business license, tax registration certificate, organization code certificate, or combined certificate and business license;

The bidder outside the customs territory shall provide valid certificate to prove valid business registration certificate.

B. 制造商应通过 ISO9001（或 GB/T19001）质量体系认证。投标人须提供制造商有效的质量体系认证证书；

B. The manufacturer of the Bid Goods shall pass Quality Management System Certification ISO9001（or GB/T19001）Certification. Bidder shall provide valid Certificate of Quality Management System Certification of manufacturer.

C. 境内产品仅允许制造商投标，境外产品接受代理商投标。境外产品使用代理商投标时，投标人应得到本次投标所投产品境外制造商的同意，并提供该产品的合法唯一授权委托书。

Domestic products are only allowed for manufacturers to bid, and agents are allowed to bid for overseas products. If the bidder is an agent, bidder shall obtain the legal and only formal authorization from the manufacturer of the goods to provide the goods for this bidding.

2014 年 1 月 1 日至投标截止日（以合同签署时间为准），投标人所投海水提升泵的制造商应具有至少 2 台套浸没式海水提升泵（海水提升泵的类型为电动潜水泵）供货业绩，且均满足流量 $\geq 2000\text{m}^3/\text{h}$ ，扬程 $\geq 55\text{m}$ ，介质为海水，供货业绩中的制造商和产地须与此次投标产品制造商和产地一致。

(3) From January 1, 2014 to the bidding deadline (based on the date of contract signing), the manufacturer of seawater lifting pump proposed by the bidder should have at least 2 sets of submerged seawater lift pumps with supply performance(The type of seawater lift pump is an electric submersible pump), and both meet the technical requirements of flow rate $\geq 2000\text{m}^3/\text{h}$, head $\geq 55\text{m}$, medium of seawater, and the manufacturer and place of origin in the supply performance must be consistent with the manufacturer and place of origin of the bidding product.

The Bidder shall furnish reference List in given form, and provide corresponding documentary evidence. The documentary evidence shall include but not limited to: 1) copies of sales contract and 2) Receiving certificate of arrival of goods(Delivery acceptance form or commissioning acceptance report). The reference evidence certification furnished by Bidder shall as least demonstrate the content show as follows: Date of signing contract, name of manufacturer, name of Goods, technical requirements (Discharge capacity/head/seawater medium) and Arrival acceptance materials.

Failure to submit performance certification documents, or failure to reflect the contract signing time, manufacturer name, goods name, relevant parameters of equipment (Discharge capacity/head/seawater medium), delivery time, or commissioning qualification time, shall be deemed as invalid performance.
