4	符合性检查	投标人名称	与营业执照、资质证书一致
5	符合性检查	投标函及投标函附录签字盖章	有法定代表人或其委托代理人签字或加盖单位章。由法定代表人签字的，应附法定代表人身份证明，由代理人签字的，应附授权委托书，身份证明或授权委托书应符合第六章“投标文件格式”的规定
6	符合性检查	联合体投标人	提交符合招标文件要求的联合体协议书，明确各方承担连带责任，并明确联合体牵头人
7	符合性检查	备选投标方案	除招标文件明确允许提交备选投标方案外，投标人不得提交备选投标方案
8	详细评审	The name of the applicant	consistent with the business license and qualification certificate
9	详细评审	The signature and seal of the bid letter	signed by the legal representative (the person in charge of the unit) or its entrusted agent or stamped with the unit seal. If signed by the legal representative (person in charge of the unit), the identity certificate of the legal representative (person in charge of the unit) shall be attached, and if signed by the agent, the power of attorney shall be attached, and the identity certificate or power of attorney shall comply with the provisions of Chapter 5 "The format of the prequalification application document"

13	详细评审	Business license	<p>1. If the bidder is a registered company in the People's Republic of China, it is necessary to provide valid business license (with independent legal personality), general taxpayer certificate/tax registration certificate, copy of organization code certificate or three-in-one business license, and stamp the official seal (all the above documents are within the validity period).</p> <p>2. If the person in charge of the unit is the same person or there is a holding or management relationship, the relevant bid shall be invalid, and the tenderer shall have the right to make decisions at any time such as rejecting the bid, disqualifying the bid, canceling the award of the bid, not signing the contract or terminate the contract after the signing of the contract, which shall be unconditionally accepted by the relevant bidder, and any losses resulting therefrom shall be borne by the bidder.</p> <p>3. If the bidder is an overseas registered company, a copy of the valid company registration certificate shall be provided and signed by an authorized representative.</p>
14	详细评审	Past Performance	<p>When bidding, the bidder shall possess at least two completed performance records of submarine pipeline laying projects for the proposed vessels in the past five years from the bid deadline (subject to the contract signing date).</p> <p>The performance certification documents provided by the bidder include: the cover page of the performance contract and the relevant signature or stamped page, the completion certificate signed by the employer, and the technical requirements of the contract scope of work are provided as supporting evidence. Performance that only involves signed contracts without substantive work is defined as having no construction performance.</p>
15	详细评审	Check on site	The tenderer has the right to carry out on-site verification of the bidding resources of the recommended winning candidates, and the bidder shall promise to cooperate with the on-site verification organized by the tenderer, and the tenderer shall decide whether to carry out the inspection or not.
16	详细评审	General Technical Requirement	Supplier to meet all the technical requirements of the tender.
17	详细评审	Crew qualification	The captain, chief mate, DPO, chief engineer, bosun, and chief electrical engineer must have more than 5 years of experience in pipelaying projects; other personnel such as first engineer, second engineer, second mate, AR&tensioner operator, roller operator, crane operator, and lifting commander must have more than 3 years of experience in offshore pipelaying and possess valid certificates for related offshore operations.
18	详细评审	Commitment Requirement	Prospective bidders are required to affirm their commitment to acquire the QHSE Certification for Contractors of Offshore Oil Engineering Co., Ltd. prior to commencing construction works. In the event of non-compliance, the Tenderer retains the discretion to rescind the contract.

19	详细评审	Scope Work	<p>1.SUPPLIER shall provide a S-lay vessel with crane suitable for the construction tasks and shall also supply the necessary oil and water for the entire chartering period.</p> <p>2.SUPPLIER shall provide personnel and resources necessary for the vessel navigation and construction except the installation personnels in the firing line, including but not limited to the superintendent for pipelaying and structure lifting, captain, chief engineer, first mate, second mate, third mate, and a full crew, maintenance team, and logistical support.</p> <p>3.SUPPLIER should provide the necessary documents for construction operations, including but not limited to company qualification documents, third-party certificates for vessels and key equipment (cranes, tensioners, AR winches, etc.), specifications, editable vessel diagrams, and equipment drawings.</p>
20	详细评审	Vessel Requirements	<p>1.There should be no less than 9 stations in the firing line, including 5 welding stations, 1 Non Destructive Testing station and 3 Joint Coating stations for the pipelay vessel with a single joint firing line system.</p> <p>2.An A/R winch should be equipped, with an operating capacity of not less than 400MT and a cable length of not less than 2000m.</p> <p>3.The dynamic positioning vessel shall be equipped with a DP2 or higher positioning system.</p> <p>4.The total capacity of the tensioner should be no less than 400MT.</p> <p>5.The pipeline recovery and PLET laydown capacity shall be no less than 400T.</p> <p>6.The pipeline with collar hang off capacity shall be no less than 400T.</p> <p>7.The PLET handling capacity (weight) of PHS shall be no less than 400T.</p> <p>8.The PLET size requirement of PHS should be no less than 14m in length and 10m in width.</p> <p>9.The laydown cable length shall be no less than 2000m.</p>
21	详细评审	Owner of Vessle	The bidder shall be the owner of the ship or a company with the same legal person and share structure as the owner of the ship.Relevant supporting documents should be provided when submit the bid document
22	详细评审	Classification certificate.	The vessel must hold a CCS or or equivalent classification certificate.
